**2. Review of December 2023 Meeting Minutes**

- a. There were two presentations given at the December 2023 Meeting.
  - i. The first presentation was about the role of cultural centers at UConn.
  - ii. The second presentation was about reaffirming UConn's commitment to diversity in admissions.
- b. December 2023 Meeting Minutes approved.

**3. Update on Anti-Black Racism Course**

- a. Wrote a proposal in the Fall 2022 semester, and presented the proposal to the Senate Executive Committee on January 20, 2023.
- b. The proposal will be an amendment to the Senate Bylaws under section 2 rules and regulations.
- c. The Senate Executive Committee gave feedback based on different categories:
  - i. How does the course fit in the general education structure?
    - 1. Currently, the course will not fit into the new general education structure.
    - 2. This will result in credit requirements/structure.
  - ii. Forecast Analysis
    - 1. A 1 credit course that will be at the 1 credit cost.
    - 2. Originally the course was going to be no charge, but it could cause issues with student financial aid if students took a required no-credit course for no cost.
  - iii. How is the course going to be graded?
  - iv. How is the course going to be audited?
  - v. Course oversight/management
    - 1. The course will be taught by instructors from different municipal disciplines.
- d. There will be a possibility of waving the course, however there will be no other course that will fulfill this requirement.
- e. The grading scheme will be based on how the instructor wants to grade the class.

**4. Graduate Student Experience in Research Survey**

- a. Kent Holsinger will be joining in the March 2023 meeting to discuss this survey. The discussion will be focused around campus climate.
  - i. Holsinger will be open to feedback about the survey.

- b. Feedback/Suggestions about survey:
  - i. GS 1210, Page 35 (disabilities question) does not offer the option “to not disclose”.
  - ii. In the section about intimidating and hostile work environments, could it add a statement item about where to report this?
  - iii. Add a question about demographics
  - iv. On page 16 about how students are receiving instruction, would it be useful to be more specific about how students are receiving online learning (synchronous vs. asynchronous)
  - v. There is a disconnect between the topics of COVID-19 vs. non-COVID topics
