- D. Updates
  - a. Drop/Add: Karen Bresciano gave an overview of what was done by this subgroup last semester.   - b. CSD (Center for Students with Disabilities): Karen Bresciano reported that the SEC is working to put together a motion for a university-wide CSD Accommodations Taskforce. Christine Wenzel shared that a few training sessions will be run this semester for faculty "come get the tea about CSD" series to support dialogue around CSD

## E. New Business

- a. Scholastic Standing review and potential bylaw changes:
  - i. 24 credit rule and Academic Standing: Jamie Kleinman summarized the issue and discussion ensued. Students who have a GPA between 1.8 and 2.0 and are taking fewer than 24 credits are considered in good academic standing but are struggling to progress. Kelly Gilbert shared that students do receive a letter of warning when they are in this GPA range. Anyone below 1.8 during their first two semesters is on academic probation.
  - ii. Additional potential changes (naming, warning status, required time away from UConn): Erin Ciarimboli summarized the issues surrounding the different stages of Academic Probation and the need to investigate potential changes to this process to be more effective in supporting students who are struggling. She shared that a comprehensive report on these concerns was also shared with the Provost's Office and many significant conversations with campus partners have taken place. The floor was opened to discussion. Jamie Kleinman proposed that at some point Erin Ciarimboli lead a subcommittee to draft a bundle of bylaw changes to affect change on this issue; any draft bylaw change presented to be discussed in this group before moving forward. Christine Wenzel, Carrie Fernandes, Jamie Kleinman raised their hands to focus on this issue.

- b. Denial of Space for Non-attendance rule: Jamie Kleinman opened the floor to Brian Rockwood to report on this issue. Brian Rockwood summarized the issue there is a policy that if a student is not in attendance, they can be dropped from a class administratively in the first ten days of a class (it is a drop and not a withdrawal, removed by the registrar and does not require the consent of the student). He added that this is extremely rare. Sharyn Rusch shared that she receives several requests from faculty in this area, even if it does not get to the level of the Registrar, particularly for lab classes. She raised concerns about the lack of clarity on this in the Course Catalog where the language does not go in accordance with the bylaw. Discussion ensued and it was agreed that the language is confusing and a change is needed.
- c. Bylaw in question:
  - i. Denial of Space for Non-Attendance: A student who is enrolled in, but does not attend any classes or laboratory meetings during the first ten days of classes may be denied a place in the course. Such non-attendance, or non-attendance later in the semester, does not constitute withdrawal; the student must officially drop the course by regular procedures or risk being assigned a failing grade.
