





How does UConn spend State funds?

State funds are used to support salaries

State support accounts for 16% of UConn's total revenues:

\$501 Million State support

16% = of total revenue

State support is only used for salaries and covers:

26%

of total employee salaries

31% of UConn salaries 19% of UCH salaries

Revenues generated by UConn cover all other costs

UConn self-generates 84% of its total revenues:

\$2.6 Billion self generated revenue

 $84^{\circ}/_{0}$ = of total revenue

UConn covers 74% of employee salaries

74% of employee salaries are covered by UConn self-generated revenue



First-year application trends at Storrs Campus continue to rise to nearly 60,000 for fall 2024 From Fall 1996 to 2023, applications at all campuses have increased **459%** and 91% since fall 2012.


... and the quality of the first-year student class is highly competitive.
