## University Senate Meeting Sept. 9, 2024 Student Union, Room 330/331 (hybrid via WebEx)

President Maric called the meeting to order at 4:03 p.m.

#### 1. Election of Moderator and Secretary

President **Maric** appointed Senator Jennifer **Dineen** as the Moderator for the Sept. 9, 2024 Meeting of the Senate and Senator **Siegle** seconded this motion. The motion was approved unanimously by a voice vote.

Moderator **Dineen** called for nominations for the Senate Secretary and Senator **Day** nominated Christine North as the 2024-2025 Senate Secretary, which was seconded by Senator **Bresciano**. The motion was approved unanimously by a voice vote.

#### Moderator **Dineen** read the **Land Acknowledgement Statement**:

"The land on which we gather is the territory of the Eastern Pequot, Golden Hill Paugussett, Lenape, Mashantucket Pequot, Mohegan, Nipmuc, and Schaghticoke peoples, who have stewarded this land throughout the generations. We thank them for their strength and resilience in protecting this land, and aspire to uphold our responsibilities according to their example."

#### 2. Report of the President

President **Maric** began with a PowerPoint presentation.

Moderator **Dineen** thanked President **Maric** for their report and asked for questions and Senator **Bush** asked for an explanation of the treatment of the students involved in the Gaza Protest Encampments. President **Maric** deferred to AVP Rhynhart and Police Chief Labonte on this matter and mentioned the option of having them meet with the SEC to provide a detailed response about the procedures and policies.

Senator **Lozano-Robledo** asked for an update on the budget situation and projections for the coming 5 years. President **Maric** stated that they met with all the unions and presented the budget that was been submitted to the Legislators and requested that CFO **Geoghegan** provide an overview of the budget. The Senate recognized CFO **Geoghegan** and they stated that the current fiscal year's budget

was less than requested from the State and that there will be a submission to the State in November or December for an additional \$10 million of ARPA funds. Next they will be working on the requests for fiscal year 26 and 27 using the directions provided by OPM and they would invite everyone that is available from the Senate to attend the Board of Trustees meeting to hear the full plan that will be presented at that meeting.

Senator **McCutcheon** asked about the Higher Ed Financing Committee that the President was a part of through OPM and asked if there was a way that a senator could be part of this committee to provide faculty perspective to the State. President **Maric** stated that this group is chaired by OPM Secretary and they identify membership to the Committee that does not include others from the University, as they have recruited the Nation Center for Higher Education Management System in Colorado to assist them.

Moderator **Dineen** thanked President **Maric** for their report and for answering the questions from the Senators.

#### 3. Introduction of Senators

Moderator **Dineen** asked for each of the Senators that are present to either stand or acknowledge their presence virtually as their name is read aloud.

#### 8. Enrollment Report

Presented by Vice President Nathan Fuerst

Vice President Nathan **Fuerst** presented a PowerPoint presentation.

VP **Fuerst** completed their presentation and asked if there were any questions. Senator **Whittaker** asked if there was a plan to reduce the need for incentives for students to obtain off-campus housing again next year and VP **Fuerst** stated that a plan will be brought to the USG leaders soon and the incentives may continue to encourage students to solidify their housing decisions early.

Senator **Lozano-Robledo** asked about the plan for seating students into classes due to the enrollment growth when the departments are dealing with budget cuts that are not allowing for more teaching capacity. VP **Fuerst** stated that this will require close work with the Provost's Office and Provost D'Alleva stated that their office is actively working with CLAS to handle the general education courses and gateway courses.

Moderator **Dineen** called for any new business.

Senator **Park Boush** asked for comment on the FASFA challenges and what is anticipated moving forward. VP **Fuerst** stated that the corrections that are needed on the FASFA have had to be done by the University's financial aid team and the golive for next year has already been moved from Oct. 1<sup>st</sup> to Dec. 1<sup>st</sup>, so they are already behind the '8 Ball' in this process.

Senator **Park Boush** followed up by asking about the risks that this may result in for University/Schools budgets. VP **Fuerst** stated that there were some students that

were not eligible for financial aid due to the FASFA issues and the University worked proactively to make those students whole for the coming year.

Senator **McCutcheon** stated that historically the office has been accurate in predictions, but this year was off by almost 10% and was wondering why this may have happened and also asked about the declining enrollment at the Avery Point campus. VP **Fuerst** stated that there are active conversations around Avery Point and all regional campuses to address enrollment concerns and the prediction issue was due to a higher than expected enrollment at the Hartford and Stamford campuses.

Senator **Greene** asked whether the enrollment numbers are available from the Graduate School as well and VP **Fuerst** stated that these numbers will be reported from the Vice Provost and Dean of the Graduate School at a later date.

Senator **Jockusch** asked about the growth at Stamford and the institution's plan for managing this moving forward. VP **Fuerst** stated that they are excited about this growth given the marketing and advertising that has taken place for the Stamford campus, so now they need to take a step back and look at issues such as housing and programs to sustain this and be sure it is done the right way.

Moderator **Dineen** thanks VP **Fuerst** for their presentation and answering of question.
