3. Motion to untable and revise (S. Stifano, S. Wilson) ARE 2215 Business Management (#27213) [Revise prereqs] – TABLED

This course was tabled over title concerns pending communication with the department. The department's response was as follows:

"The chosen name was discussed in our faculty meeting, and the vote for this course was unanimous. We specifically chose the name to NOT be agribusiness management, because is it indeed broader, as is our program. The management practices taught are appropriate for many students looking to apply their skills in a variety of areas in a business setting. Using the word "agribusiness" as a modifier would be overly narrow. The fact that the course is offered in CAHNR and the description includes Food and Agriculture, is sufficient to signal that we do indeed cover agribusiness, but that this is not the sole application for the course content. Our students need this course as a complement to the other courses we offer in our major and long standing minor in Business Management and Marketing (our marketing team has placed in the top three in the annual national competition, winning in the last year!). Limiting the title to agribusiness management would not be useful for students."

#### Discussion

- One member felt the response from ARE is still problematic. If CAHNR is teaching a general business course, it's possible it overlaps significantly with offerings from the School of Business.
- In the chat: "With the new comments, [the concern] is not only now about the title, but about the content itself."
- One member warned about straying too far into the territory of telling people
  what they can and can't teach. Nevertheless, they felt it would be common
  courtesy to have the discussion with business about the course, if only to avoid
  confusion.
- In the chat: "Also students doing the minor they mention they might be getting credit for the same content twice, once in ARE and once in Business classes."
- In the chat: "If this were two units in CLAS, we'd ask the proposing unit to consult the unit who had the logical claim to the title's subject matter."
- Should we (Senate C&C) contact the School of Business? No. It should be the department's responsibility to reach out and ensure there isn't too much overlap and that there are no concerns.
- Ultimately Senate C&C does not have veto power to reject the course, but it is our responsibility to ensure the department has done their due diligence in terms of communicating with relevant parties. The School of Business can take action if they feel there's an issue.
- In the chat: "Our influence is withholding a vote until we're content. If we're NOT content, we should clarify what we'd need to get there."
- One member suggested the following message to ARE in the chat: "Because this
  course already exists, we imagine a conversation has already occurred between
  the School of Business and CAHNR. We just want to ensure that consultation
  has occurred, since Senate C&C routinely tracks curricular overlap between
  colleges."
- S. Stifano motion to retable ARE 2215 (#27213). Z. Boudah seconded. The motion to retable was passed unanimously.

  - Motion to add (K. Bott, J. Chandy) NURS 2300 Planetary Health: Understanding the Relationship of Human and Environmental Health (#26536) [New TOI-4] Proposed Catalog Copy
    - NURS 2300. Planetary Health: Understanding the Relationship of Human and Environmental Health

(3 credits)

This course explores The relationship between human health and the natural environment through the planetary health lens, including Planetary health recognizes the interdependence of human health and the stability of Earth's ecosystems and acknowledgment ing of the profound impact of anthropogenic activities on both. Students will delve into Exploration of the complex web of interactions between human societies and the natural world to gaining insight into how the degradation of environmental systems can profoundly influence human health

outcomes. The course will examine various Aspects of planetary health includeing the consequences of climate change, air and water pollution, deforestation, biodiversity loss, and the intensification of extreme weather events.

#### Discussion

- A streamlined version of the catalog copy was offered (see above).
- It was noted that consultation needs to happen with various departments for this course as well, in particular with EEB (2100E), EVST/ENVS, and ERTH.
- The Provost's Office wants to be sure these conversations are happening.
- One member noted that one of the things they look for in catalog copy in CLAS is clear disciplinary framing. There is no reference to Nursing at all in this description.
- In the chat: "It'll be important in that email to note that it would be helpful if nursing was more prominent in the course description."
- S. Stifano motioned to table. A. Lozano-Robledo seconded. The motion to table NURS 2300 (#26536) pending consultation with environmentally-focused departments was passed unanimously.

#### VIII. Other Business

- One member asked if it is within the purview of this committee to discuss the issue of the majors that may be cut.
- The Senate will definitely be discussing this at its next meeting.
- S. Croucher explained the selection process for the program review that was announced. She noted that there's a lot of misinformation going around. There is no plan to eliminate the majors/programs that didn't meet the 100-student threshold, which was an arbitrarily-chosen number. What the administration wants to do is look at things like if we're running lots of upper-level courses for very few students. Are there majors where there's no feeling of community or where students don't interact much? There is nothing in the documents that in any way suggests programs will be eliminated. People have had an "agenda" in sharing the list, and they're needlessly creating fear. The administration is only trying to create a space for schools and colleges to have a discussion about the structure of their programs.
- The USG representative offered the student perspective. *The Daily Campus* story was a bit inflammatory, but he's assured current students they will still have a major. Anything currently existing would not be fully removed until all current students completed it.
- It was confirmed in the chat that, "Any degree we currently offer has to be continued through to students completing their degree."
- In the chat: "I hope the President/Provost will make similar comments during the next Senate session."
- Members warned that information was likely being skewed through the "telephone game."

• In the chat: "We call it leveling in the organizational communication literature. As opposed to sharpening (where folks highlight key points and omit the rest) and assimilation (where folks manipulate the rumor for personal benefit.)"
