This data included an analysis of the % of students filling out the FAFSA, vs the % that are Pell grant eligible.

Degree Seeking Undergraduate Students

- Sue Peters explained that shifts in Pell eligibility between 2023 and 2024 were impacted by changes in the government's metric for determining eligibility.
- Sue Peters explained issues with the FAFSA which took place last year and impacted all students interacting with the system (new and continuing). She added that the process is still not smooth and that we can expect to see a continuance issues moving into next year. The 2025-2026 FAFSA is scheduled to be going live on December 1, 2024 and the Dept of Education is running Beta testing groups of the new system. UConn is part of Beta Test 3 and the Office of Financial Aid, in collaboration with the One Stop Office, are working to identify students who would like to fill out a FAFSA to be a part of this Beta Test process. Students who have signed up to participate in this, should be given a 6-day window and a unique URL to participate starting next week. The Office of Financial Aid will not know the names of the students participating in this Beta Test.

- Leo Lachut thanked Sue Peters for their presentation and opened the floor to questions. Kimberly Duby shared that she has heard from students that they feel they are receiving less financial aid and asked if that concern is rooted in reality or not. Sue Peters answered that the change in metrics actually made it so that many students would have received more financial aid, not less, but that family income changes can also play a role in the calculation. Leo Lachut raised concerns about potential tuition increases and how that might impact students with financial aid needs. Sue Peters stated that need-based aid has gone up every year, alongside tuition increases; however, she could not state if those increases have kept pace enough with the tuition costs. Discussion also ensued around helping students understand their financial responsibility to the university, particularly those who have high financial need and may be taken on the burden of higher loan amounts. Sue Peters added that the Office of Financial Aid will be sending letters to all students who fill out the FAFSA highlighting their financial commitment in coming to UConn, taking their loans into account. Arthur Galinat asked whether other students – graduate students, international students, etc- will receive this communication. Sue Peters answered that this communication is only sent to students who fill out the FAFSA. Leo Lachut also shared that he has had students approach him in the past saying that they received more money than they expected, and Sue Peters confirmed that there are COVID funds that must be used by December 31 of each year and that their office will assign any additional funding to students with high financial need when they become available. Leo Lachut and Tina McCarthy thanked Sue Peters for their presentation and asked if Sue would present again at a future meeting, especially considering the Early Decision process that is beginning and will be done before the FAFSA is open to application.

Updates, Last year and moving forward

- First Gen Week Updates and Information: Leo Lachut shared that about 30% of students at Storrs and 50% of students at regional campuses identify as “first gen,” and that National First-Generation Recognition Day is November 8th each year and was celebrated by several offices on campus. There will be a week-long series of events, and all committee members are encouraged to participate and tell their colleagues about this series. <https://firstgen.uconn.edu>
