## 1. Cynthia Constanza & Isaac Barber

a. //policy.uconn.edu/recent-updates/

Cynthia Costanzo shared that a taskforce that worked over the summer on clarifying policy and policy changes. She invited Isaac Barber to go into more detail regarding the scheduling and management of outdoor spaces on different campuses. He shared that outdoor spaces are managed by a scheduling office, and each office has its own procedures for booking an outdoor space. Cynthia Costanzo reviewed the <a href="Outdoor Activities Policy">Outdoor Activities Policy</a> which became active on August 24, 2024. She also shared that the <a href="InForm">"InForm" Website</a> will be rebranded as "Get Informed" so that information and resources can be easily accessible to students.

The floor was opened to questions and Erica Granoff asked whether faculty and staff who schedule and manage events will receive training on these new policy changes. Discussion ensued regarding a lack of clarification regarding the policy regulations (if any) on camping. Leo Lachut asked about any external groups that would like to come to campus, citing the upcoming election. Isaac Barber shared that this is also managed by the scheduling office to ensure safety and security of these proposed events; they do not do content review of the event.

2. How will the university manage moving forwarding incoming class size as it relates to class size, off campus housing, transportation, staffing needs

Leo Lachut introduced the topic and opened the floor to Cynthia Costanzo who went into more detail about the re-established office for off-campus support, which will be led by John Armstrong. She also shared that this fall was the largest incoming class, and the highest number of on-campus students have been housed as a result. She said that the full "residential stock" around the Storrs campus, including both on- and off-campus options, is important to consider. Discussion ensued regarding housing on the Stamford campus and students' access to other resources, such as a recreation center.

Leo Lachut introduced the topic and said that we can circle back on this at a later date after checking in with leadership, citing Tadarrayl Starke specifically, for updates on this.
