1. Welcome & Introductions:
2. Approve Minutes - August meeting: minutes were approved unanimously
3. Center for International Students & Scholars (CISS): Arthur Galinat presented a presentation summarizing the resources offered by the CISS office to international students and faculty. He added that the focus of this office is to support international students through their entire UConn experience, but academic and cultural, and that supports continue post-graduation to students who opt to stay in the United States and work for up to three years within the terms of their student visa. Arthur Galinat gave details on the welcome and support programs, English language workshops, and Socio-Cultural/networking events. He also gave details on the UCAELI Support and Pathway program, which is a program specific for students who have consistently been performing poorly in language intensive courses and need additional language focused courses. Leo Lachut thanked Arthur Galinat for their presentation and opened the floor to questions. A question was asked regarding the graduation rate of international students compared to the

university's aggregate rate and Arthur Galinat said he would look for those numbers and report back. A question was also raised regarding the common challenges that international students are facing today and Arthur Galinat shared that affordable housing for international graduate students is a big challenge.

4. Karen McComb Director, Health Promotion and Community Impact Wellness Designation: Emily Pagano presented on National Recovery Month, which runs through the month of September and shared a number of events that are taking place during the month ([flyer](#)). Emily Pagano also shared that UConn has joined the [Okanagan Charter](#), which serves as a call to action for universities to become a health-promoting university following the aspirational guidelines laid out in the Charter. As a part of this, UConn has created official institutional commitments, as [laid out online](#). She added that there will be both a student and a staff advisory board for this initiative and nominations for either are welcome.
