- 2. Approve Minutes January meeting: minutes approved unanimously.

Old Business

Nurse Navigators at Regional: Leo Lachut introduced the topic, summarizing that there
are concerns coming from regional campuses that students are misinterpreting the
services offered, due to the name "nurse," which may imply direct patient care. Tina
McCarthy clarified the role of this service and asked the committee for feedback.
Nathanael Okpych suggested a name change to "Student Health Navigators." Others
suggested "Health Navigators" on its own, to avoid the implication that it's a student-run
service. "Husky Health Navigators" was also suggested. Tina McCarthy thanked the
committee for their feedback.

- New Fee structure: Tina McCarthy stated that fee structures as they relate to eligibility
 for certain services would be something to dig into at a future meeting, perhaps by
 inviting a speaker to address this.
- Parking: Leo Lachut introduced the topic and summarized the many ways in which this topic has been raised and addressed in the past. Erica Granoff raised concerns about parking enforcement on regional campuses. Kim Duby shared that Andy Kelly has addressed some of these issues with her office, particularly for students who have fewer than 54 credits (and are not granted on-campus parking), sharing that his report showed a surplus of parking spaces on campus, but in less desirable locations (like Discovery Drive). Clarification for a further parking plan was also requested. Cynthia Costanzo shared concerns that the shuttle schedule from the parking options on Discovery Drive does not offer services on the weekend. Additional concerns were raised regarding the accessibility of parking fees, citing them as too expensive. Concerns were also raised regarding the increase in electrical scooters and other small, motorized vehicles on campus, and the safety surrounding this. Tina McCarthy recommended connecting with the UConn Transportation Advisory Committee that focuses on motorized transportation on campus and is run through the Office of Sustainability. In summary: lack of enforcement, lack of spaces, and financial barriers are the key issues of concern.
- Transportation issues, Less availability of routes, Hours, ridership?: addressed in the above
- Clearer weather policy for class cancelation: tabled considering the motion being brought forward at the March 3, 2025 Senate meeting by the Scholastic Standards Committee. Cynthia Costanzo shared that there is additional work ongoing with weather impacts on staff and she can bring that information to a future meeting.

New Business

- Call for agenda items
- Review of proposed edits to Student Welfare Committee charge: Leo Lachut introduced the topic and discussion ensued. Discussion particularly centered around "financial stability" and discussion will continue.
- Kat McCarthy, Asst. Director, One Stop: Decision Release Information: Kat
 McCarthy shared that admissions decisions will be released tomorrow at 5 p.m.
 and added that admissions received more than 62,000 applications this year, which
 is double the number in a decade. Additionally, financial aid decisions are going out
 with admissions offers. Due to this high volume, Kat McCarthy shared that high call
 volumes are expected, and the office is planning accordingly.

- Supporting regional campus students and class attendance: Leo Lachut shared
 that he has heard of this concern and asked the committee for any insight they may
 have about how this issue is being addressed. This conversation will continue at a
 future meeting.
- On campus Housing for fall 25 concerns: Cynthia Costanzo shared that every single incoming student for Fall 2025 will have housing. The demand exceeds the supply, and it has been a challenging situation to manage.
- Tina McCarthy shared a brief update from the February 26th Board of Trustees meeting.
