- Guest- Andy Kelly, Assoc. Director of Logistics: Tina McCarthy introduced Andy Kelly who gave updates on the below items:

1. Cost of parking: Andy Kelly explained that parking costs are covered solely by parking fees and that permit fees are not increasing going into the next academic year. He added that they are trying to find a way for student parking permit costs to be added on fee bills so that they may be covered by financial aid. A question was raised regarding parking enforcement on regional campuses and residence halls. Andy Kelly shared that his team does their best to make it down to enforce as resources allow, adding that parking enforcement in Hartford is performed by an outside vendor. Andy Kelly shared that lots at residence halls are not enforced by UConn, but with an outside vendor.

of spots available (credit minimum and where the spots are located): Andy Kelly reviewed the most available parking spots/lots, highlighting that unfortunately most available spots are not in the closest lots.

- 2. transportation options to get them from that parking location to their class/work/activity in a timely manner: questions were also raised regarding transportation to/from the developing off campus housing units and whether any transportation is being taken into account for these.
- 3. need for safe trail/paved sidewalks from off campus housing in proximity to campus

- 5. More Scooters and they are moving very quickly: Andy Kelly shared that Kyle Muncy is leading an effort with an external scooter providing company to address this speed geofencing, scooter parking, etc.
- 6. Not very many places for students who are using them to store them securely in designated areas which creates the need for them to be locked on other items that at times block sidewalk etc.

- Suzanne Peters shared that Student Life & Enrollment identified almost \$1,000,000 in funding to award to students who had outstanding balances (needs-based). This aid went to 353 students just before Spring Break.
