## **Old Business**

- On campus Housing for fall 25 concerns: Cyndi Costanzo shared that approximately 300 rising sophomores applied late and that any rising sophomore that applied on time did receive housing. Some rising juniors and seniors who applied on-time were waitlisted and the office continues to prioritize continuing students as spaces become available. Currently approximately 175 continuing students remain on the waitlist. Concerns were raised regarding the cost of available housing, citing The Oaks, which is more expensive. Cyndi Costanzo shared that there is some availability in North, which is rate 1, and that there are two rates available at The Oaks (rates 6 and 8). Cyndi Costanzo added that they are recommending students to accept housing, even if it is not their desired option, as there will be a process over the summer to help students make change to their assignment. She added that students interested in off-campus opportunities should contact John Armstrong for assistance. A question was raised regarding Stamford Campus housing and Cyndi Costanzo shared that more housing will be offered on the Stamford campus this year; long-term lease at "The Boulevard" which will be partially available this fall, and fully available in the next academic year.
- Supporting our international students (Arthur Galinat): Arthur Galinat summarized the situation that several international students are facing with SEVIS record revocations, as well as the actions taken and support offered by their office, as well as specific student concerns.
